Enclosed is your pool registration information for the upcoming season. This year we are continuing with the same pool company as last year – CBC Pool Management. Please read the enclosed information regarding your Application. The following Fees apply:

### WECA Residents

Check should be made payable to WECA. Allow at least 7 days from the date of submission of your Application to receive your passes. Application **MUST** be received by May 24, 2011 to receive your passes in time for opening day which is May 28, 2011. Passes will **NOT** be hand delivered. You may arrange to pick up your passes during office hours (Monday, Tuesday, Wednesday, and Thursday mornings from 9-12 and Tuesday evenings by appointment) or have them mailed to you.

**- Pool fees cannot be submitted on the same check as dues payments. These payments are processed differently and if you include your pool fee with your dues payment, your check will be returned. Check or Money orders only.**

**Guest passes** are only available for purchase through the office. If you are unable to obtain passes during the scheduled office hours, call the office to make other arrangements or see a pool committee member on site.

Picture passes will be issued again this year for all season passes at the request of the Pool Company and lifeguards. If we have a picture on file from last year, we can use the same one for your new pool pass. If a picture is not on file, you can contact the WECA Office at 610-873-7208 to make arrangements to have your picture taken.

## **WECA POOL RULES AND REGULATIONS**

POOL HOURS: 12:00 pm - 7:00 pm

DATES: May 28<sup>th</sup>, 29<sup>th</sup>, and 30<sup>th</sup> only (weekend ONLY and Holiday)  
Saturdays and Sundays only 6/4 & 6/5, 6/11 & 6/12  
Daily from June 18<sup>th</sup> through August 28<sup>th</sup>  
September 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> (weekend only and Holiday)

Check the website for details regarding upcoming events.

The WECA Pool is a private community pool.

Members must sign in and present picture pass to the Lifeguard EVERY DAY.

Guests must sign in and submit pass to the Lifeguard, guest pass is a signal day use only.

No more than two guests admitted per Member.

Swimming is allowed only during Pool hours and only when Lifeguard is on duty.

Appropriate swim wear is required. No shorts or cut-offs allowed.

Pool passes must be available upon request by lifeguard, Board or Pool Committee members at all times.

Children under age 13 must be accompanied by a parent/adult age 18 or older at all times.

If the Parent/Adult leaves premises, so must their children less than 13 years of age.

Parents/Guardians are responsible for watching children in the baby pool at all times and must be present at all times.

Babies must wear "swimmies" (waterproof swimming diaper no exception).

Children age 5 and older are not permitted in the Baby Pool (special exceptions to be made at the discretion of the lifeguard).

No Alcoholic Beverages permitted.

No Glass Containers permitted.

No Loud Music – if it can be heard throughout the pool area – it's too loud.

Portable (battery operated) radios/CD/MP3 players only – nothing to be plugged into the pool house outlets.

No Barbecues (Unless organized and operated by the Recreation Committee or WECA Board).

No Running or Horseplay.

No Bikes or skateboard permitted within the pool gates.

Lifeguard has the right to revoke any pool privileges at his/her discretion.

Lifeguard and/or Pool Management Company has the authority to close the pool at any time due to weather, pool condition or equipment failure.

Lifeguards are here to protect member and guest. Sitting/Loitering at Lifeguard table is strictly prohibited.

If Lifeguard asks you to leave you must leave immediately.

**POOL PRIVILEGES CAN BE REVOKED FOR NON-PAYMENT OF DUES DURING THE SEASON. BREAKING OF ABOVE RULES CAN RESULT IN SUSPENDED OR REVOKED MEMBERSHIP BY LIFEGUARDS OR WECA BOARD.**

**Swimming Pool Release of Liability and Assumption of Risk**

RELEASE AND WAIVER OF LIABILITY FOR USE OF THE WEDGWOOD ESTATES COMMUNITY ASSOCIATION (WECA) RECREATION CENTER & SWIMMING POOL. PLEASE NOTE, THE WECA SWIMMING POOL IS A PRIVATE COMMUNITY POOL.

I recognize that the use of recreational facilities, including the Wedgwood Estates Swimming Pool, and all equipment and facilities contained therein (collectively, the "Recreational Area"), have inherent risks of injury. I, my spouse, assignees, heirs, guardians, and legal representatives hereby voluntarily indemnify, release from liability, agree to defend and hold harmless Wedgwood ESTATES and its officers, members, employees, agents, representatives, and any department, organization or group affiliated therewith (collectively "WECA") for any accident, injury, illness, death, loss, theft, damage to person or property, or other consequences suffered by me arising or resulting directly or indirectly from my use of the Recreation Facilities, including but not limited to claims arising from or related to WECA's negligence and/or products liability, including strict products liability. In the event that I am injured, I agree to assume any financial obligation, either through my health insurance, or through some other means, for any medical costs that I incur.

WECA, assumes no responsibility for any medical expenses, injury, or damage suffered by me in connection with my use of the Recreation Facilities.

IT IS MY INTENTION BY SIGNING BELOW TO EXPRESSLY ASSUME ALL RISK OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE UPON MYSELF, TO THE EXCLUSION OF WECA, AND TO EXEMPT AND RELIEVE WECA FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH.

By signing this agreement, I waive my right to bring any legal action now or at any time in the future to recover compensation or obtain any other remedy for any injury to myself or my property or for my death, however caused, arising out of my use of the Recreational Facilities. I further agree that I, my spouse, assignees, heirs, guardians, and legal representatives will not make any claim against, sue or attach the property of WECA for any loss or damage resulting from my use of the Recreational Facilities. I am aware of the potential dangers incidental to recreational sports activity and that this is a release of liability, a waiver of my legal right to collect damages in the event of injury, death or property damage, and a contract between WECA and me, and I sign it of my own free will. I expressly agree that this release is intended to be as broad and inclusive as the State of Pennsylvania will allow and that if any portion is held invalid, I agree that the balance shall, notwithstanding, continue in full legal force and effect.
