#### Rules and Regulations –

- **Court Hours** – 10AM to Dusk
- **Members, Residents, and Guests Only** – Courts are available, to all owners and residents, registered in advance.
- **Guests** – Guests must be accompanied by a member. No more than (3) guests on the court at a time.
- **Use by Children** – For safety reasons, all children under age 15 must be accompanied by a parent, guardian, or other adult 18 years of age or older. This adult is responsible for supervising the children to ensure their safety and compliance with these rules.
- **Time Limits** – For the benefit of all players, there is a 1 hour time limit for play – Court changes players on the hour
- **Apparel** – Sneakers or tennis shoes must be worn on the courts.
- **Decorum** – Courtesy and sportsmanship must be demonstrated at all times. Disruptive behavior, profane language, shouting and physical altercations are prohibited.
- **Electronic Devices** – No electronic devices (other than cell phones). Music is prohibited.
- **Food & Drinks** – No food, glass objects, or alcoholic drinks are allowed within the court enclosure. Only beverages in plastic bottles may be consumed courtside.
- **Smoking** – Smoking is prohibited within the court enclosure.
- **Banned Equipment/Personal Items** – Sports equipment and other items not directly related to the game of tennis are not allowed in the court enclosure. These include, but are not limited to skates, skateboards, bicycles, wheeled vehicles, portable structures, personal seating, and ice chests. WECA reserves the right to determine acceptable/not acceptable equipment at any time.
- **Pets** – Pets must remain outside of the court enclosure, at all times.
- **Court Access/Security** – Tennis Court gates require a key code for entry. Gates must remain closed, and locked, AT ALL TIMES. Do not prop the gates open or provide facility access to others.

- **Mischief and Vandalism –**
  - Do not tamper with poles or hang on nets
  - Any balls thrown over the court fence, into the court area, will result in loss of your ball
  - No climbing or tampering with any fences, gates or locks.
  - Violators will be charged for any damages, criminal mischief and trespassing
  - Area is under 24 hour video surveillance
- **Use At Own Risk** - All members and their guests using the court do so at their own risk. Wedgwood Estates shall not be responsible for injuries, accidents or lost or stolen items.
- **HOA Account** – Only residents in good standing with the Association may access the facility.
- **Violations** – For rules violations or failing to remain in good standing, WECA reserves the right to restrict you from using the courts and block your key code until such time as they see fit. **Deedholders/Lessees (All on Deed/Lease must sign):**

- I understand association dues must be kept current in order to use the amenities, and failure to keep my account current will result in loss of access to the court.
