



2022 POOL REGISTRATION

Enclosed is your registration application for the current pool season. Please read the enclosed information carefully. The following registration fees apply:

(ALL pool passes are valid for current season only- season passes are non-refundable)

REGISTRATION FORM MUST BE COMPLETED, IN FULL. RELEASE OF LIABILITY MUST BE SIGNED BY ALL PASS HOLDERS. ALL PAGES MUST BE RECEIVED WITH APPROPRIATE PAYMENT. ANY MISSING INFORMATION OR SIGNATURES WILL RESULT IN REGISTRATION BEING DELAYED AND/OR HELD FOR ALL PASS HOLDERS IN THE HOUSEHOLD.

MEMBER PASSES/PHOTO REQUIREMENTS – Member (season) passes are non-refundable and non-transferrable. Picture passes will be issued for all season passes.

2022 PICTURE GUIDELINES: Close-up face shots of all applicants must be submitted via email. Pictures are to be taken against a light color wall or door ONLY, and emailed to the office for processing – info@wedgwoodestates.com. We will NOT use prior year pictures, NO EXCEPTIONS. All pictures emailed must be identified by full name of passholder.

GUEST PASSES – Guest passes are one-day single use only. Pass must be presented to the pool attendant upon entry, and liability release must be signed. Guest Passes are available for purchase through the WECA office, in advance. **(3) day minimum processing time is required.** Pool attendants will NOT sell passes at the pool, nor will they permit entry without valid passes. Guest passes must be purchased by a registered member (valid member pass must be shown for purchases). An adult season pass holder must be present with their guests, at all times, while in the pool area. Unused guest passes are refundable if returned to the WECA office **by September 23, 2022.**

PAYMENT – To receive your pool passes, complete and return all pages with appropriate payment. A **separate check** must be made payable to WECA (do NOT combine on the same check or include with your dues payment). These payments are processed differently and if you include your pool fees with your dues payment, your check will be returned, and passes will be delayed. Registration forms received without proper payment will not be processed.

PROCESSING TIME – Allow **3 business days, minimum**, from the date of receipt of your application, for passes to be processed. **The office is closed to in person contact.** You may drop off (drop box) or mail your application with payment, and you will be notified by email when your passes are ready and they have been given to the pool attendants.

DELIVERY – You will be notified by the office when they are available for pick-up from the pool attendants. DO NOT enter the pool facilities until you have been notified that passes are completed.

MEMBERSHIP CUT-OFF – Season passes will NOT be sold after Friday, 8/26/22.

There will be no admittance to the pool area without proper passes - NO EXCEPTIONS

POOL RULES AND REGULATIONS

NO LIFEGUARD IS ON DUTY. ALL WHO ENTER SWIM AT YOUR OWN RISK.

POOL HOURS: 12:00 pm - 8:00 pm

Weekends Only – Saturday 5/28/22 – Sunday 6/19/22 – **FREE SWIM**
Full Time Daily – Monday 6/20/22 through Sunday 7/17/22– **FREE SWIM**
Full Time Daily – Monday 7/18/22 through Monday 9/5/22 – **MEMBERSHIP ONLY/PASSES REQUIRED**
Labor Day Weekend – Saturday 9/3/22 – Monday 9/5/22 – **MEMBERSHIP ONLY/PASSES REQUIRED**
CLOSING DATE WILL BE ADVISE AFTER MONDAY 9/5/22 (EMAIL TO PAID POOL MEMBERS)

*** Dates are subject to change in the event the CASD calendar is adjusted*

- The WECA Pool is a private community pool. Membership is exclusive to owners and permitted owner assigned occupants (registered tenants) only.
- Members must sign in and present photo pass to the Pool attendant EVERY DAY. Pool passes must be available at all times, for presentation upon request by a pool attendant and/or WECA Board
- Children, under age 15, must be accompanied by an adult member, AT ALL TIMES. If the Parent/Adult leaves the gated area, so must their children less than 15 years of age.
- Parents/Guardians are responsible for watching children in the main pool & baby pool & **must be present with them AT ALL TIMES.**
- Guests must sign in and submit guest pass and signed liability release to the Pool attendant. Guest passes are issued for single day use only. Guest pass must be completed with guest name and date of use.
- **No more than two guests admitted per individual Member, or four guests per family.** Adult member must be present at all times with their guests.
- **Children, age 5 and older, are NOT permitted in the Baby Pool**
- **APPROPRIATE** swimwear is required. This is a family pool. NO shorts or cut-offs, NO thongs or the like are permitted.
- Babies must wear “swimmies” (waterproof swimming diaper) – NO EXCEPTIONS
- No Alcoholic Beverages permitted.
- No Glass Containers permitted.
- No Smoking – no smoking is permitted inside the fenced pool area. This includes cigarettes, cigars, pipes and vape devices.
- No Loud Music – if it can be heard throughout the pool area – it’s too loud.
- No Running or Horseplay.
- No water guns, blasters, water splash balls, water bombs or the like
- No Bikes or skateboards permitted within the pool gates.
- Pool attendant has the right to revoke any pool privileges at his/her discretion.
- No pets are permitted in the pool area. This includes service dogs.
- HOA Management or their designated Pool attendant have the right to remove any individual from the pool area that does not comply with rules or is continuing disruptive behavior after warning. I asked to leave you must leave immediately.
- Pool attendant and/or HOA management have the authority to close the pool at any time due to weather, pool condition, or equipment failure.
- Please contact the WECA office with any issues regarding the pool.
- By obtaining a pass for yourself, spouse, family member or your children, you acknowledge all members and guests are swimming at your own risk.
- Swimming is allowed only during pool hours and only when Pool attendant is on duty, otherwise it is considered trespassing, and violators will be fined and/or household memberships will be revoked.

POOL PRIVILEGES WILL BE REVOKED FOR NON-PAYMENT OF DUES DURING THE SEASON. BREAKING OF ABOVE RULES MAY RESULT IN SUSPENDED OR REVOKED MEMBERSHIP BY POOL ATTENDANTS OR WECA BOARD, WITHOUT WARNING OR NOTICE.

RELEASE AND WAIVER OF LIABILITY FOR USE OF THE WEDGWOOD ESTATES COMMUNITY ASSOCIATION (WECA) RECREATION CENTER & SWIMMING POOL. PLEASE NOTE, THE WECA POOL IS A PRIVATE COMMUNITY POOL. MEMBERSHIP IS EXCLUSIVE TO OWNERS AND PERMITTED OWNER ASSIGNED OCCUPANTS ONLY.

- I recognize that the use of recreational facilities, including the Wedgwood Estates Swimming Pool, and all equipment and facilities contained therein (collectively, the "Recreation Area"), have inherent risks of injury. I, my spouse, assignees, heirs, guardians, guests, and legal representatives (collectively referred to as "Me", "I", "Myself", "My") hereby voluntarily indemnify, release from liability, agree to defend and hold harmless Wedgwood Estates and its officers, directors, members, employees, agents, representatives, and any department, organization or group affiliated therewith (collectively "WECA") for any accident, injury, illness, death, loss, theft, damage to person or property, or other consequences suffered by Me arising or resulting directly or indirectly from My use of the Recreation Facilities, including but not limited to claims arising from or related to WECA's negligence and/or products liability, including strict products liability. In the event that I am injured, I agree to assume any financial obligation, either through my health insurance, or through some other means, for any medical costs that I incur.
- WECA assumes no responsibility for any medical expenses, injury, or damage suffered by Me in connection with My use of the Recreation Facilities.
- IT IS MY INTENTION BY SIGNING BELOW TO EXPRESSLY ASSUME ALL RISK OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE UPON MYSELF, TO THE EXCLUSION OF WECA, AND TO EXEMPT AND RELIEVE WECA FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH, FOR MYSELF, FAMILY, AND GUESTS.
- In consideration of My use of the Association Amenities, and by signing this agreement, I waive my right to bring any legal action now or at any time in the future to recover compensation or obtain any other remedy for any injury to Myself or My property or for my death, however caused, arising out of my use of the Recreational Facilities. I further agree that I, my spouse, assignees, heirs, guardians, guests, and legal representatives, will not make any claim against, sue or attach the property of WECA for any loss or damage resulting from My use of the Recreational Facilities. I am aware of the potential dangers incidental to recreational sports activity and that this is a release of liability, a waiver of my legal right to collect damages in the event of injury, death or property damage, and a contract between WECA and Me, and I sign it of my own free will, and on behalf of my family, guests and myself. I expressly agree that this release is intended to be as broad and inclusive as the State of Pennsylvania will allow and that if any portion is held invalid, I agree that the balance shall, notwithstanding, continue in full legal force and effect.
